ARTICLES OF INCORPORATION OF NAPLES ON THE GULF DEVELOPMENT CORP.

The undersigned incorporator(s) for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt(s) the following Articles of Incorporation.

ARTICLE I

NAME: The name of the corporation herein called either "the corporation" or "this corporation", is Naples on the Gulf Development Corp.

ARTICLE II

PRINCIPAL OFFICE: The principal place of business and mailing address of this corporation is 2386 Linwood Ave, Naples, Florida 34112.

ARTICLE III

SHARES: The number of shares of stock that this corporation is authorized to issue is one-thousand (1000) shares of stock. Each share of said stock shall have a par value of one United States Dollar (\$1.00). Said stock is comprised of one class which has unlimited voting rights and is entitled to receive the net assets of the corporation upon dissolution.
