We enclose the much traveled uniform business report. We have no record of having received a UBR at the beginning of 2002. Being new to the USA and to the procedures, we totally overlooked it. We were obliged to return home for new visa processing in July, and our mail was sent on for us, to Leicestershire in the U.K.

We did not receive it up to the time we returned to Florida, September 6, 2003, but it did arrive there after we had left, and was again redirected to us, but arrived here too late for the September 10 filing.

In the event of non-delivery, is the USB returned to you ? Or perhaps kept locally ? Needless to say, and we accept that ignorance is no excuse, we didn't set out to avoid filing, or to be so heavily penalized. Our question is, why do we have to maintain corporate status as a subsidiary business owned entirely by its parent in the U.K ?

While writing, it is interesting to note that although previously corrected by us, the addresses for the officers and directors remain incorrect.
