# ARTICLES OF INCORPORATION

OF

### ARTICLE I - NAME:

SECRETARY OF STATE TALLAHASSEE, FLORIDA

The name of this corporation is: G.T. LAWN SERVICES OF N.W. FLORIDA, INC., hereinafter referred to as the "Corporation". ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Department of State.

## ARTICLE III - PURPOSE:
