ARTICLES OF INCORPORATION OF

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I CORPORATE NAME

The name of the corporation shall be D. J. M. Palm Beach Holdings Corporation, and the corporation's principal address shall be I 100 Northwest 133rd Terrace, Sunrise, Florida 33322.

ARTICLE II TERM OF EXISTENCE

This corporation shall have perpetual existence commencing upon the filing of these Articles of Incorporation.

ARTICLE III NATURE OF BUSINESS AND POWERS

The purposes for which the corporation is organized are to engage in the business of purchasing, owning, operating and utilizing commercial real estate, and the general nature of the business to transacted by this corporation is to engage in any and all business permitted under the laws of the United States of America and the State of Florida.

The preemptive right of any holder is determined by the ratio of the authorized shares of common stock held by the holder to all shares of common stock currently authorized.
