Articles of Incorporation:

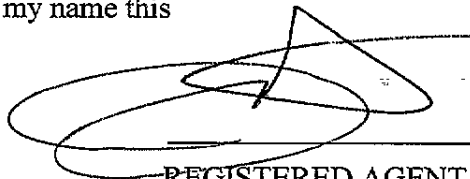
