## ARTICLES OF INCORPORATION OF

#### ARTICLE I

The name of this corporation is:

AMERICAN AVIATION CONSULTANTS, INC.

#### ARTICLE II

This corporation shall have perpetual existence commencing on the date of the filing of these Articles of Incorporation.

#### ARTICLE III

This corporation is organized for the purpose of transacting and engaging in any and all activity or business permitted under the laws of the State of Florida or of the United States.

#### ARTICLE IV

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is 10,000 shares of common stock at \$1.00 par value. Said stock shall be issued pursuant to a plan under Section 1244 of the Internal Revenue Code of 1986, as amended.

corporation. The preemptive right of any holder is determined by the ratio of the authorized and issued shares of common stock held by the holder and all shares of common stock currently authorized and issued.
