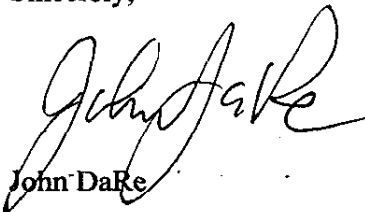
Dear Division of Corp.,
