The undersigned incorporator for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I -NAME

The name of this corporation is CORONA EXPRESS, INC. (hereinafter referred to as the "Corporation").

ARTICLE II -PRINCIPAL OFFICE


