

ARTICLE I - NAME

The name of this corporation is U. S., LUMBER, INC. with a principal office and mailing address of 840 SE 131ST STREET, OCALA, FL 34480.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of the filing of the Articles with the Department of State.

ARTICLE III - PURPOSE
