#### ARTICLE I.

The name and initial address of this Corporation shall be: VACATION RESERVATION NETWORK, INC., 440 Columbia Drive, Suite 500, West Palm Beach, Florida 33409, Attn: Howard Levy, with the privilege of having its offices and branch offices at other places within or without the State of Florida.

#### ARTICLE II.

This Corporation may engage in any activity or business permitted under the laws of the State of Florida.

#### ARTICLE III.

The capital stock authorized, the par value thereof, and the characteristics of such stock are as follows:
