**ARTICLES OF AMENDMENT  
TO ARTICLES OF INCORPORATION  
OF SEMC, INC.**

Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Business Corporation Act, SEMC, Inc., a Florida corporation, Document P01000107988 (the "Corporation"), hereby adopts the following amendment to its Articles of Incorporation:
