After checking our corporation status online we discovered we needed to be reinstated. I contacted your office to rectify the matter and was told to fill out the attached form along with an explanation of why we are late in filing.

We have no record of a notification being sent to us concerning the matter. This may be due to the fact that we had considerable business interruption due to the hurricanes. We not only suffered damage to our property but significant loss of business due to loss of power and telephone service. We were severely affected by the second hurricane as well. Both hurricanes were direct hits to Palm Beach County where we are located. Station Nation Inc. collected no insurance money due to the fact that our wind policy supercedes our regular insurance policy so loss of income and property damage such as our canopy and gas pumps were not covered.
