ARTICLES OF INCORPORATION

The undersigned Subscriber, whom is licensed to practice dental medicine, desiring to form a corporation in the State of Florida hereby makes, signs, and subscribes these Articles of Incorporation in order to form a professional corporation under the laws of the State of Florida, and hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME

The name of the corporation is **LOURDES MARIA CANO, D.M.D., P.A.**, hereinafter referred to as the "Professional Association", principal address of 7816 Silverado Court David, Florida 33024.

ARTICLE II - NATURE OF BUSINESS

The general nature of the business to be transacted by this Professional Association is: To provide and promote Medical, Dental, Surgical, and Scientific research and knowledge; to furnish related laboratory and clinical services and to practice all aspects of the Dental Profession.

To conduct business in, have one or more offices in, and hold, mortgage, sell, convey, lease or otherwise dispose of real and personal property, including franchises, agencies, patents, copyrights, trademarks and licenses in the State of Florida and in other state and countries.

To contract debts and borrow money, issue and sell or pledge bonds, debentures, notes and other evidence of indebtedness and execute such mortgages, transfers or corporate property, or other instruments to secure the payment of corporate indebtedness as required.

To guarantee, endorse, purchase, hold, sell, transfer, mortgage, pledge or otherwise

acquire or dispose of the shares of the capital stock of, or any bonds, securities, or other evidence of indebtedness created by any other corporation of the State of Florida, or any other state or government, and while owner of such stock, to exercise all the rights, powers and privileges of ownership, including the right to vote such stock.

To make and enter into all contracts and do everything else necessary, suitable and proper for the accomplishment, furtherance or attainment of any one or all of the aforesaid objects and purposes.

The foregoing and following provisions shall be construed as objects and powers in furtherance and not in limitation of the general powers and conferred by the laws of the State of Florida and the enumeration in these articles of specific powers and object shall not be held to limit, restrict in any manner, the powers of this Professional Association; but this Professional Association may do all and everything necessary, suitable or proper for the accomplishment of any purpose or object, either alone or in association with other Professional Associations, firms or individuals.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of stock that this Professional Association is authorized to have outstanding at any one time is Sixty (60) shares of common stock, having a nominal or par value of ONE and 00/100 ----(\$1.00) DOLLARS per share.

ARTICLE IV - INITIAL CAPITAL

The amount of capital with which this corporation will begin business is not less than ONE THOUSAND (\$1,000.00) DOLLARS.

ARTICLE V - TERM OF EXISTENCE

This corporation is to exist perpetually.

ARTICLE VI - ADDRESS

The street address of the initial registered office is hereby designated to be 7816 Silverado Court, Davie, Florida 33024. The corporation may change its registered office or registered agent pursuant to the provisions of Section 607.037 Florida Statutes.

ARTICLE VII - REGISTERED AGENT

The registered agent of the corporation shall be LOURDES MARIA CANO, D.M.D., and the registered agent address is 7816 Silverado Court, Davie, Florida 33024.

ARTICLE IX - MANAGEMENT BY SHAREHOLDERS

The Professional Association shall be a close corporation within the meaning of, and governed by, the Florida Close Corporation Article. The business of the Professional Association shall be managed by its shareholders pursuant to Section 608.72 of the Florida Statutes, and there shall be no director.


ARTICLE XI - AMENDMENT

These Articles of Incorporation may be amended in manner provided by law. Every amendment shall be approved by the Shareholders, and approved at a Stockholder's meeting by a majority of stock entitled to vote thereon, unless all stockholders sign a written statement manifesting their intention that certain amendment of these Articles of Incorporation be made.

ARTICLE XII - DISSOLUTION

The corporation may be dissolved at any time (1) by unanimous written consent of the shareholders; or (2) on the affirmative vote of the holders of at least two thirds (2/3) of the outstanding shares of the corporation entitled to vote thereon. On dissolution, the corporate property and assets shall, after payment of all debts of the corporation, be distributed to the shareholders pro rata, each shareholder to participate in the distribution in direct proportion to the number of shares held by him.





