

To Whom it May Concern:

This letter is in regards to the reinstatement of my business, Blizzard Air Inc. On 07/30/03 I went to pull a permit to do a job, and over heard a conversation regarding reinstatement of corporations. When I inquired about this with the county employee, I was informed that all corporations are required by the State of Florida to be reinstated every year, and a renewal notice is usually sent to the owner. I informed the worker that I never received any documentation regarding a renewal. I then called the State to verify this information, and was told that this is correct, and that the renewal notices are sent in January. I was informed to send a letter explaining why I have not sent my renewal notice for reinstatement in the last two years, and was told if I sent \$300.00 that my corporation would be reinstated with no penalties. On 11/09/01 I incorporated my business. On 12/01/01 I moved to an apartment awaiting the building of my house. I submitted a change of address form to the post office, to ensure I receive my mail. My house took 15 months to build, and on 03/21/03 I moved into my house. I also submitted a change of address form to the post office. I am not sure why I did not receive this notice, but I am requesting that you reinstate my corporation as I am a small business owner, with no employees, and will not be able to afford any severe penalties.
