ARTICLES OF INCORPORATION OF



PLANNED RESPONSE SYSTEMS, INC.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation to do business for profit.

ARTICLE I

The name of this corporation is PLANNED RESPONSE SYSTEMS, INC...

ARTICLE II

The existence of the corporation shall begin on the filing of the corporation papers with the Department of State and shall be perpetual.

ARTICLE III

The street address of the principal office of the corporation is 2720 Imperial Lane, Sebring, FL 33872 and the initial registered agent for the corporation is DAWN L. AVIS, 2720 Imperial Lane, Sebring, FL 33872.

ARTICLE IV

The maximum number of shares this corporation is authorized to issue is 7000 shares, with par value of \$1.00 per share, all of which shall be common shares. All common shares shall be identical with each other in every respect and the holders of common shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote. Each shareholder, upon the issuance of any new stock of this corporation of the same kind, class or series as that which he or she already holds, shall have the right to purchase his or her pro-rata share thereof (as nearly as may be done without the issuance of fractional shares) at the price it is offered to others.
