THE UNDERSIGNED ACTING AS SUBSCRIBER OF A CORPORATION UNDER THE FLORIDA CORPORATION LAW, ADOPT THE FOLLOWINGS ARTICLES OF INCORPORATION.

ARTICLE I

THE NAME OF THE CORPORATION IS, SOLID FOUNDATION CONSTRUCTION COMPANY.

ARTICLE 11
