We, the undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the Laws of the State of Florida.

ARTICLE I Name of Corporation

1. The name of the Corporation shall be: IMAGE PROMOTIONS SERVICES, INC.
