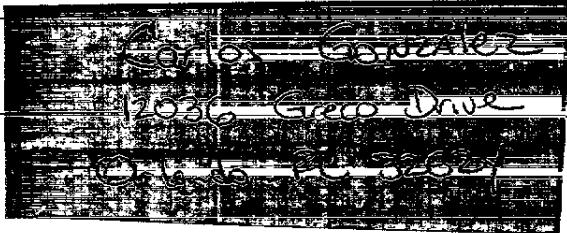

## ARTICLES OF INCORPORATION

The undersigned, for purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation.

### ARTICLE 1.

The name of the Corporation is: JAG ENTERPRISES OF ORLANDO, INC.

### ARTICLE 2.

The duration of the Corporation is perpetual.

### ARTICLE 3.

The general purposes for which the Corporation is organized are the following:

A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purposes limits this general purpose in any way.

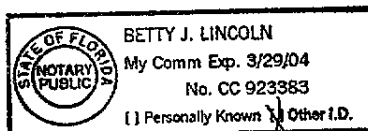

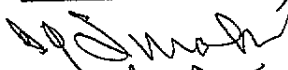
