
ARTICLES OF INCORPORATION

OF

ZEN PERFORMANCE, INC.

ARTICLE I. NAME

The name of this corporation shall be ZEN PERFORMANCE, INC.



ARTICLE II. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filing of these Articles Of Incorporation by SHARYN M. AUGER. This corporation's duration shall be perpetual.
