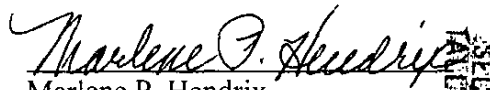
## ARTICLES OF DISSOLUTION

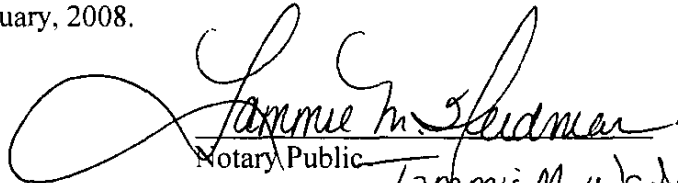
