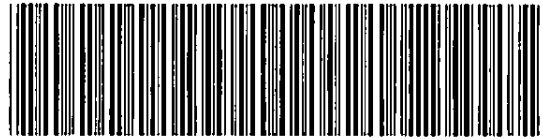

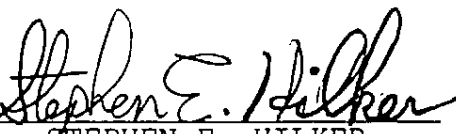

ARTICLES OF DISSOLUTION
