ARTICLE I
Name

The name of the corporation is RSV CORP., a Florida corporation.



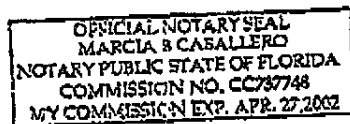
