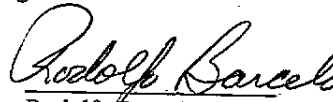
ARTICLE VII AMENDMENTS

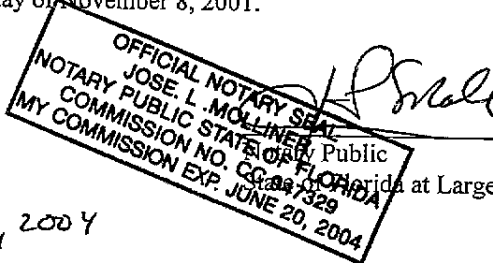
