**ARTICLE I: NAME**

The name of the corporation is: **Collision Center & Wrecker Service of North Dade, Inc.**

**ARTICLE II: NATURE OF BUSINESS**

The general nature of the business to be transacted by this corporation is to do all things which natural persons might lawfully do in the premises as follows: Automotive and truck body repair, painting, towing and related products and services and other investments of every kind, nature, and description.

**ARTICLE III: CAPITAL STOCK**
