**ARTICLES OF INCORPORATION
OF**

PRECIOUS CARGO STUDENT LIMO SERVICE, INC.

The undersigned Incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE 1 - NAME

The name of the Corporation shall be: Precious Cargo Student Limo Service, Inc.

ARTICLE 2 - INITIAL PRINCIPAL OFFICE

The initial principal office of the Corporation shall be at: 429 Vista Oak Drive, Longwood, Florida 32779.

ARTICLE 3- SHARES

The Corporation shall have the authority to issue seventy-five (75) shares of common voting stock of a single class.

ARTICLE 4 - INITIAL REGISTERED OFFICE AND AGENT

4.1 - INITIAL REGISTERED OFFICE: The street address of the Corporation's initial registered office shall be: 429 Vista Oak Drive, Longwood, Florida 32779.

4.2 - INITIAL REGISTERED AGENT: Britt Cadelo will be the Corporation's Initial Registered Agent.

ARTICLE 5 - BOARD OF DIRECTORS

5.1 - NUMBER OF DIRECTORS: The Initial Board of Directors shall have three (3) Directors. A Director may be removed only for cause.
