I. NAME

The name of the corporation is GORMAN'S LEASING, INC.

II. TERM OF EXISTENCE

This corporation shall have perpetual existence.


IX. SUBSCRIBER AND INCORPORATOR

X. AMENDMENTS



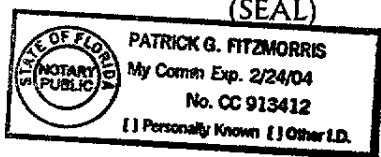


