To Whom It May Concern:

During the latter middle of 2002, my family and I were temporarily relocated from Ft Lauderdale, FL to the Tampa, FL area because I had secured a contract for work. Initially it was believed that this was a temporary move which has extended to a permanent move. During this transition and until a few weeks ago, there were some noticeable problems with the forwarding of the mail to the new (temporary) address. It is believed that due to this situation, I did not receive a notice to submit my corporation annual report.

Recently it has been brought to my attention, that my corporation, Jake, Inc., was administratively dissolved on 09/13/2003, because an Annual Report was not submitted. I immediately began checking and confirmed that mail has been redirected to other locations and/or returned to senders. Although I still maintain the listed residence in Ft Lauderdale, FL, the mail was returned and on some occasions believed to have been stolen by local neighborhood kids. I further coordinated with my respective accountant and was sad to have been informed that he has been gravely ill and unable to work in a full capacity as he has in the past. In this connection it could not be ascertain if he had or had not forwarded the necessary documentation (Annual Report). As a result of these unfortunates and unforeseen mishaps, an annual report for 2003 was not submitted.

As demonstrated by my most humble, honest and good faith intentions to right this wrong, I plead to the Division that the reinstatement fee be waived.

I have attached an annual report and the required fee.

Your sensitivity and understanding to this situation is noteworthy and most appreciative. In the event that this matter is not approved, please advise immediately.
