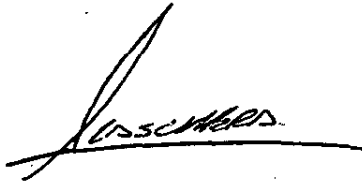
In conclusion, I would like to make up this inconvenient and send again a new check so the company that I represent will not have problems in the future.
