ARTICLES OF INCORPORATION

OF

BAYSIDE BOAT MAINTENANCE, INC. In Compliance with Chapter 607 and/or Chapter 621 F.S. (Profit)

These Articles of Incorporation are made and subscribed for the purpose organizing a corporation for profit under the Florida Business Corporation Act.

Article I - NAME
