LAHASSFUT STATE The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act hereby adopt the following articles of incorporation:

#### <u>Name</u>

The name of the corporation is B K T Z. Inc. and it's principal place of business is 3921. Vaill Point Terrace, St. Augustine, Fl 32086. Its mailing address is P. O. Box 4498 St. Augustine, Fl 32085-4498.

#### ARTICLE TWO

#### <u>Duration</u>

The term of existence of the corporation is perpetual.

#### ARTICLE THREE

#### <u>Purpose</u>

The corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

#### ARTICLE FOUR

#### Capital Stock

The aggregate number of shares which the corporation has authority to issue is 1,000, all of which shall be common shares with a par value of \$1.00. All of said stock shall be payable in cash, property, labor or services at a just valuation to be fixed by the Board of Directors at a meeting called for that purpose; and any and all such shares so issued, the full consideration for which has been paid or delivered shall be deemed fully paid stock and not liable to any further call or assessments thereof, and the holder of such shares shall not be liable for any further payment thereon.

The amount of capital with which this corporation may commence business is \$100.00.

The right shall be deemed waived by any shareholder who does not exercise it and pay for the share pre-empted within thirty (30) days of receipt of a notice in writing from the corporation stating the prices, terms and conditions of the issue of shares and inviting him to exercise this pre-emptive rights. This right may also be waived by affirmative written waiver submitted by the shareholder to the corporation within thirty (30) days of receipt of notice from the corporation.
