ARTICLE I
NAME

The name of this corporation is MS TIMBERLANE, INC.

ARTICLE II
PRINCIPAL OFFICE OF BUSINESS

The street address of the initial principal office of this corporation is 1415 Timberlane Road, Suite 217, Tallahassee, Florida 32312.

ARTICLE II
DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III
PURPOSE

INDEMNIFICATION

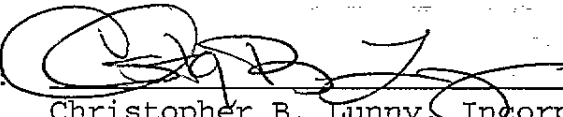
The corporation shall indemnify any Officer or Director or any former officer or director, to the full extent permitted by the law.

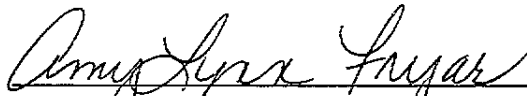

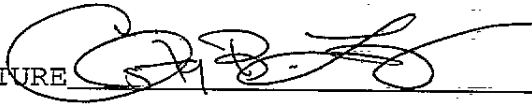
