#### ARTICLES OF INCORPORATION

# OF A A AAUTO TOWING & ROAD SERVICE, INC.

#### ARTICLE I -- NAME

The name of this corporation is A A AAUTO TOWING & ROAD SERVICE, INC.

#### ARTICLE II -- DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

#### ARTICLE III - PURPOSE
