The undersigned incorporator to these Articles of Incorporation, by these Articles form a corporation for profit, pursuant to the laws of the State of Florida.

FIRST. The name of the corporation is **Loger Group, Corp.**

SECOND. The period of duration of the corporation is perpetual.

THIRD. The purpose is to engage in any activities or business permitted under the laws of the United States and of the State of Florida.

FOURTH. The aggregate number of shares of Capital Stock which the Corporation has authority to issue is one thousand (1000) all of which shall be one class of common stock having a par value of \$0.50

FIFTH. The address of its initial registered office is 4141 North Miami Avenue, Suite 210-04, Miami, Florida 33127, and the name of the initial Registered Agent at such address is Ana Ines Demarsico.

SIXTH. The initial Board of Directors will consist of one (1) directors whose names and addresses are:



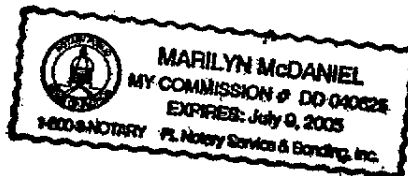
