ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this corporation is: COMART, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

This corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation or any

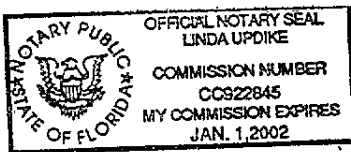
