Article I

Name. The name of this Corporation is Menon Wave Systems, Inc.

Article II

Principal Office. The address of the principal office of the Corporation is 5200 N.W. 43rd Street, Suite 102, #327, Gainesville, FL 32606.

Article III

Duration. The period of duration of this Corporation shall be perpetual, commencing on the date of execution and acknowledgment of these articles.

Article IV

Purpose. 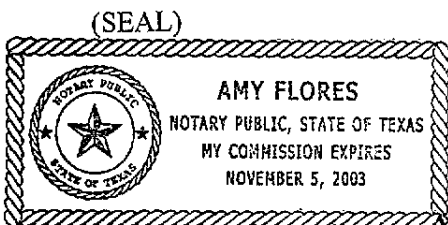
