In compliance with the requirements of F.S. Chapter 607, the undersigned, being natural persons, hereby act as incorporators in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is UCC Total Home of Fort Lauderdale, Florida Inc.

ARTICLE II

The existence of the corporation shall begin upon filing these articles with the Florida Department of State.

ARTICLE III

The street address of the principal office of the corporation is 315 SE 7th Street, Suite 200, Fort Lauderdale, FL

ARTICLE IV

The maximum number of shares this corporation is authorized to issue is 1000, par value \$.01 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of common shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE V


