I am enclosing this explanatory letter as instructed by your office.

In October of 2001 I gave a deposit to my attorney to form the corporation S & S Melrose Inc. The corporation was formed in early November of 2001.

On September 24, 2002 I paid the remaining balance to my attorney and picked up the corporate books. Upon looking over the books I found a letter from the Florida Department of State explaining that a Uniform Business Report must be filed each year by May 1st. This was the first time I had ever been informed of such a report as I have never owned any kind of corporation or small business in the past, and it is now about 5 months past May 1st of the first year of the existence of the corporation. Even though I didn't collect the corporate books until yesterday, the corporation was actually formed late last year. No one at the attorneys' office or anywhere else informed me that there was any time critical action that had to be taken on my part.

As per the instructions of your office I downloaded the accompanying form last night, called the IRS this morning to acquire an Employer Identification Number for the corporation, and express mailed the forms to you with the \$150 fee.
