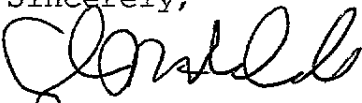

ARTICLES OF INCORPORATION
OF
P.C. TRUCKING & COMPANY, INC.

The undersigned hereby makes, subscribes, acknowledges and files these Articles for the purpose of forming a corporation under the Laws of the State of Florida:

ARTICLE I - NAME

The name of the corporation shall be P.C. TRUCKING & COMPANY, INC. The location and mailing address of the corporation is 16030 East Burns Drive, Loxahatchee, Florida 33470.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE

ARTICLE VII - INCORPORATORS

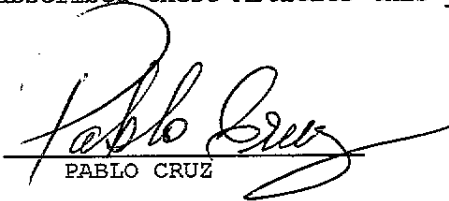

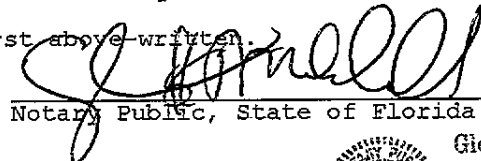

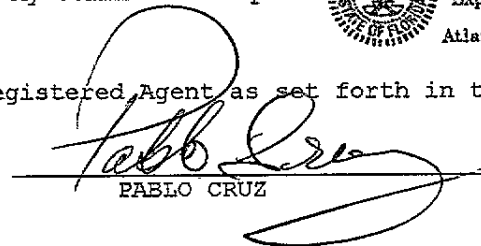
