ARTICLES OF INCORPORATION PINELLO INVESTMENT GROUP, INC.



ARTICLE I - Name

The name of this corporation is PINELLO INVESTMENT GROUP, INC.

ARTICLE II - Principal Location

The principal location is 1036 Derbyshire Road, Daytona Beach, FL 32117.

ARTICLE III - Duration

This corporation shall have perpetual existence.

ARTICLE IV - Purposes

The general purposes for which this corporation is initially organized are as follows:

The maximum number of shares of stock which this corporation is authorized to have outstanding at any time shall be 5,000 shares of common voting stock with a par value of \$0.01 per share. All stock issued shall be fully paid.

ARTICLE VI - Preemptive Rights

Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his prorata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VII - Initial Registered Office and Agent
