ARTICLE I-Name

The name of this corporation is Bishop Ranch, Inc.

ARTICLE II- Principal Office

The address of the principal office is 3337 Evergreen Road, Lorida, Florida 33857 and the mailing address is Post Office Box 519, Lorida, Florida 33857.

ARTICLE III-Duration

This corporation shall have perpetual existence.

ARTICLE IV-Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE V-Capital Stock

ARTICLE XI-Amendment

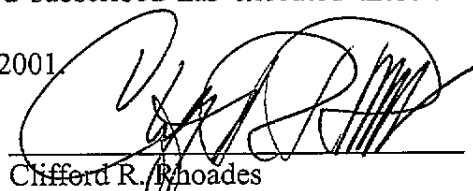

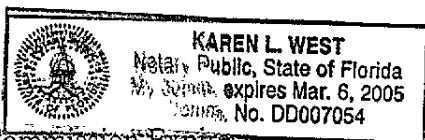
