ARTICLE I
CORPORATE NAME

The name of the Corporation is Patricia Quiroga Corporation.

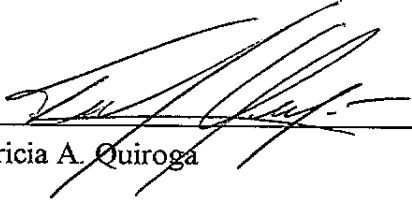

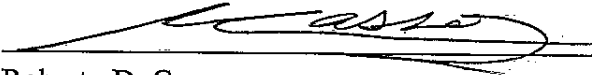
