

#### ARTICLES OF INCORPORATION

### BANANA, INC.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following articles of incorporation for such corporation:

ARTICLE I. NAME AND ADDRESS: The name and address of the corporation is: BANANA, INC., 949 Center Avenue, Holly Hill, Florida 32117.

ARTICLE II. TERM OF EXISTENCE: The period of its duration is perpetual.
