# ARTICLES OF INCORPORATION

OF

#### **SUPER SPORTS & SCUBA, INC.**



#### ARTICLE I

The name of this corporation shall be SUPER SPORTS & SCUBA, INC. and its principal address is Richey Plaza, 7129 U.S. Highway 19, New Port Richey, Florida 34652.
