

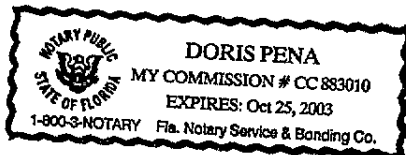
- FIRST: The name of this corporation is **THE PAPER GIRL, INC.**

- SEVENTH: The name and address of the incorporator is Lydia Chammas Losas, 6770 Southwest 52nd Street, Miami, Florida 33155.




