I, the undersigned, whose name is hereunto subscribed, make this certificate for the purpose of forming a corporation to be known as RICHARD N. MARAVEL, M.D., P.A., and hereby associate ourselves together for the purpose of becoming such corporation for profit under the laws of the State of Florida for the purpose and with the rights, powers and objects hereinafter set forth as follows:

ARTICLE I

NAME

The name of the corporation shall be RICHARD N. MARAVEL, M.D., P.A.

ARTICLE II

ADDRESS


