The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation.:

Article 1-Name

The name of the corporation is J.L. Cami Enterprises, Inc.

The corporation is organized to engage in any activity or business permitted under the laws of the United States and the state of Florida.

Article 11-Incorporator

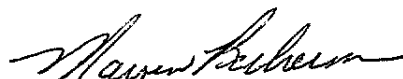

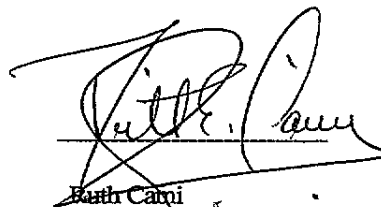
