Articles of Incorporation

THE UNDERSIGNED, ACTING AS INCORPORATOR OF A CORPORATION UNDER THE FLORIDA BUSINESS CORPORATION ACT, ADOPTS THE FOLLOWING ARTICLES OF INCORPORATION:

- FIRST: The name of the corporation is CLICK TECHNOLOGIES, INC.
- SECOND: The period of its duration is perpetual.
- THIRD: The date and time of the commencement of the corporate existence shall be the date of the filing of these Articles by the Department of State.
- FOURTH: The purpose for which the corporation is organized is to engage in the transaction of any or all lawful business for which the corporation may be incorporated under the provisions of the Florida Business Corporation Act.
