ARTICLES OF INCORPORATION

OF

RESOURCE CONSERVATION TECHNOLOGIES, INC.

The undersigned, for the purpose of forming a corporation under the provisions of Chapter 607 of the Florida Statutes, hereinafter referred to as the Corporation, hereby agrees to the following:

ARTICLE I - NAME

The name of the Corporation shall be RESOURCE CONSERVATION TECHNOLOGIES, INC. The street address of the initial principal office address of the Corporation shall be 4708 Manatee Avenue West, Bradenton, Florida 34209 and the mailing address shall be the same.

ARTICLE II - PURPOSE AND POWERS


