ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is Safari Title,



ARTICLE II - PRINCIPAL OFFICE

The mailing address of this corporation shall be: 8600 NW South River Drive Miami, Florida 33166

ARTICLE III - PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.
