### ARTICLES OF INCORPORATION

OF

J & K DOZER, INC.

## ARTICLE I - NAME:

The name of this corporation is: J & K DOZER, NC., hereinafter referred to as the "Corporation".

### ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Department of State.
